

Strategy Overview

Brazos Capital of Raymond James Moderate tactical ETF portfolio is a global asset allocation portfolio managed to be consistent with the risk orientation of a moderate investor. The strategy is globally diversified and will invest in risk-appropriate mix of equity, taxable, and non-taxable fixed income and alternative market segments. With a target allocation of 40% equity and 60% fixed income, portfolio allocation decisions will be applied at the broad asset class level first and then tactically within the various fixed income and equity market segments.

Investment Philosophy

Our investment philosophy is built around the belief that top-down, market segment allocation drives portfolio performance. We focus first on our exhaustive evaluation of the global macroeconomic picture so that we can allocate our portfolios to the most attractive market segments within an asset allocation while remaining diversified. We believe that our blend of fundamental, technical, and relative valuation analysis along with our top-down approach provides the most meaningful impact on long term performance and risk management.

Investment Process

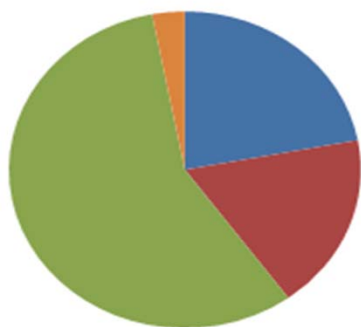
